Sub:- APRVM (SSA), Hyderabad - Issue of alternative sanctions for additional classrooms for the year 2012-13 – Certain instructions issued – Reg.

All the Project Officers in the state are informed that administrative sanction has been issued to around 90% of classrooms sanctioned for the year 2012-13 in a phased manner based on the norms of RTE Act and strength of children in schools. It is noticed from the monthly reports that some of the classrooms have been grounded and the process is in progress. This is being so, proposals have been received in this office from some of the Project Officers for issue of alternative sanctions duly cancelling the rooms sanctioned earlier. The main reasons stated by the Project Officers for cancellation and issue of alternative sanctions are (1) non availability of sites (2) existing rooms are in dilapidated condition (3) rooms are not required due to less strength (4) non feasibility for vertical expansion etc., without proper justification and certification from the concerned authority.

Further, it has been brought to the notice of the under signed that some of the Project Officers have already given alternative sanctions at district level and requested for ratification of the orders issued by them. They are informed in this regard that instructions were given many a times that alternative sanctions should not be given at district level with a view to utilize the sanctioned classrooms in a judicious manner as per requirement so as to provide minimum infrastructure facilities to all schools in the state as per RTE norms.

In the circumstances state above, all the Project Officers are once again instructed not to give any alternative sanctions for the construction of additional classrooms at district level. Any deviation in this regard will be viewed seriously and action will be initiated against the Project Officer and EE concerned. They

are further requested to furnish the proposals for alternative sanctions if any in the formats enclosed (Format-A: For cancellation of classrooms, Format-B: For issue of alternative sanctions). The proposals should be furnish with required certificates for various items as mentioned below:

Sl. No.	Name of the certificate required	Issuing authority / person
1.	Non availability of site	Headmaster and SMC concerned
2.	Dilapidated classroom	Executive Engineer (PR)
3.	Non feasibility of vertical expansion	Executive Engineer (RVM)
4.	Details of class-wise enrolment and existing rooms	Headmaster concerned

Hence, the Project Officers are requested to furnish the proposals with complete details as mentioned above to avoid delay in issue of Alternative sanctions.
